Members that wish to resign their membership must do so in writing fifteen (15) days prior to the start of the membership year (e.g. resignations for memberships commencing October 1, 2022 must be submitted prior to September 15, 2022).

Inappropriate or offensive behavior and abuse of or damage to the Country Club facilities will result in suspension or dismissal of membership without a refund.
