PUBLIC NOTICE MAILING REQUIREMENTS

In accordance with Section 21-3 of the Village of North Palm Beach Code of Ordinances, you are required to notify the general public of your proposal and to provide members of the public with a contact number to obtain additional information. The attached instructions, specifications and list of materials provide the guidance you will need to meet the Village's public mailing requirements. Please read carefully and mail your public notices without delay.

All notices shall be provided by first-class mail, unless otherwise required by community director. Mail notices shall be postmarked no later than the minimum number of calendar days as required as stated below.

Mail for all privately initiated applications shall be provided to all property owners of record, excluding property owned by the applicant, within 500 feet of the property to which the development order application or amendment relates.

The list of property owners shall be derived from the most recent official tax roll of Palm Beach County. The applicant shall provide an affidavit attesting to the completeness and accuracy of the property owner's list.

- The applicant shall provide and mail and required notices, and provide an affidavit that notice was sent to all property owners included in the property owner's list.
