SIGN BUILDING PERMIT CHECK LIST

All permit plans are required to be scaled and dimensioned to demonstrate that the proposed signage meets the code size requirements. Site Plan is required for all new signage. Existing signage can be marked on an aerial or survey.
Monument/Ground Sign
1. New or Existing Monument Sign: (provide dimensions for the overall sign)
2. Sign Face Area (width, height & total sq ft) for each of the following elements: name of the business, logo and nature of the business
3. Total Sign Face Area (width, height & total sq ft for combined sign face elements)
4. Sign Setback (ft) from property line
5. Required Landscaping (3ft around the entire base of the sign)
Wall Sign
1. New or Existing Wall Sign (provide dimensions for the overall sign)
2. Building Height (ft and stories)
3. Sign Height as installed to top of wall sign and distance from roofline (ft)
4. Building Setback (ft) from front property line
5. Sign Face Area (width, height & total sq ft) for each of the following elements: name of the business, logo and nature of the business
6. Total Sign Face Area (width, height & total sq ft for combined sign face elements)

Awning Sign (permitted on Northlake Boulevard in NBOZ only)

1. New or Existing Awning Sign (provide dimensions for the overall sign)
2. Building Height (ft and stories)
3. Sign Height as installed to top of wall sign and distance from roofline (ft)
4. Building Setback (ft) from front property line
5. Sign Face Area (width, height & total sq ft) for each of the following elements: name of the business, logo and nature of the business
