The parade route is approximately one mile from NPB Village Hall (501 US Hwy 1) to Anchorage Park (603 Anchorage Dr.). We invite sport teams, clubs, organizations, businesses, troops and neighborhood groups to participate by entering a marching group, a vehicle or especially a float. There is ***no entry fee!***

The parade's lineup will begin at 9:30 a.m. with an 11:00 a.m. start time. Immediately following the parade is the village's Heritage Festival at Anchorage Park from 12:00 p.m. – 8:00 p.m. Please understand that candies, trinkets, etc., are only permitted to be handed out to spectators from the floats/vehicles, not thrown. Participants can walk and hand items to parade viewers. No water guns allowed.
